Key Importance



Key Importance

- Solid Fuel Ducted Ramjet technology is combinedly produced by India and Russia.
- It will assist both India's surface-to-air and air-to-air missiles to perform healthier and enhance their strike capability, making them extra lethal.
- Thus, India will have quickest long-range missiles in 2 categories with protection from intimidating attacks.
- Its effective usage in missiles will mark India's entry into first-class club of countries that utilises next-generation missile technology against manoeuvring targets.
 Difference between SFDR and Conventional Missiles
- Solid Fuel Ducted Ramjet is propulsion technology different than that of unadventurous solid fuelled or liquid-fuelled missiles.
- Currently, lot of conventional missiles practices booster configuration with solid/liquid propellants, which have restrictions against manoeuvring target.
- This is because mortal stage of conventional missiles cannot deliver sufficient energy to maintain their pace to hit targets.
- Solid Fuel Ducted Ramjet technology eliminates this drawback by remarkably enhancing endgame manoeuvrability of missile at mortal stage when its seeker is locked onto target.

Press Council of India reconstituted on - 31st May 2018

The Union Government re-formed the Press Council of India on May 31 st, 2018, for a 3 years term. However, the names under medium newspaper group have not been acknowledged yet as the matter linked to it is sub-judice.

- Uttam Chandra Sharma, Pravat Kumar Dash, K.Sreenivasarao, Meenakshi Lekhi and Chhayakanta Nayak were designated for the 2 nd term in the refurbished Press Council of India.
- Members designated to the Press Council of India from different companies were Sushma Yadav from the UGC, Manan Kumar Mishra from the Bar Council of India and K.Sreenivasarao from the Sahitya Akademi.
- Future on May 22nd, 2018, former Supreme Court judge C.K.Prasad was selected as the Chairman of the Press Council of India for a 2nd term.

Denmark Parliament banned wearing of face veils in public on - 31st May 2018

Parliament of Denmark barred the wearing of face veils- burqa and niqab, in public places, on May 31 st, 2018. This is a initiative that will criminalise Muslim women who selected to wear the burqa. The Danish parliament voted 75-30 with 74

The restriction was maintained by the ruling liberal-conservative coalition parties, the farright People's Party and the antagonism Social Democrats, who trust that face veils are conflicting to the Danish values. Highlights of the legislation banning face veils in public

- The law prohibits the wearing of full-face niqab, balaclavas, face-covering masks and fake beards.
- It does not bandit headscarves, turbans, traditional Jewish Kippa and winter clothing including scarves and motorcycle helmets.
- Denmark's Justice Minister Soren Pape Poulsen informed that police will not order criminals to remove their veils, however, would charge penalty from them.
- Penalties will vary from 1000 Danish crowns/USD 160 for a 1st offense to 10000 crowns for a 4th violation.

India's First Advanced Forensic Lab dedicated to women related cases to come up in - Chandigarh

Foundation of "Sakhi Suraksha Advanced DNA Forensic Laboratory" was placed in the Central Forensic Science Lab campus, Chandigarh. It is India's 1st advanced forensic lab devoted for crimes connected to women for in-time deliver justice. Key Points

- The advanced lab at par with global standards will help to address gap in forensic DNA analysis of incomplete sexual assault cases in the nation.
- The laboratory has been formed as model forensic lab and will be imitation in other parts of the nation.
- Five extra such advanced forensic labs will come up in Mumbai, Chennai, Guwahati, Pune

and Bhopal in the upcoming three months bringing total least annual handling capacity of labs to 50000 cases.

The laboratories in Chennai and Mumbai will be formed with capital from Ministry of Women and Child Development, while outstanding three laboratories would be formed with money by Ministry of Home Affairs.

Units of Sakhi Suraksha Advanced DNA Forensic Laboratory

- There are 4 units i.e. sexual assault and homicide unit, human identification unit, paternity unit, and mitochondrial unit. Apart from Homicide and Sexual Assault Unit, other 3 units are interconnected. They will work to study cases related to crime against females.
- Paternity Uni will be helping in solving cases related to criminal parenthood, gender selection and child substitution in hospitals.
- Human Identification Unit will play crucial role to resolve cases of missing person/children.

Mitochondrial Unit will conduct mitochondrial-DNA analysis in such cases where regular DNA analysis is not possible due to highly dishonoured samples. It can also be utilised to well explore family relationships.

Online Analytical Tool to monitor foreign contributions under FCRA launched by - Government

The Union Ministry of Home Affairs released an Online Analytical Tool to enable closer monitoring of flow and usage of foreign contributions acknowledged by various firms registered/permitted under Foreign Contribution (Regulation) Act, 2010. The web grounded tool will benefit to efficiently

- It has analytical structures to conduct immense data mining and information exploration.
- o It has been joined with FCRA listed entities bank accounts via Public Financial Management System for updating transactional information on a real-time basis.

Did you know?

There are about 25,000 active firms listed under FCRA, 2010. Such firms have received overseas contributions worth Rupees 18,065 crores from overseas donors for various social, cultural, economic, educational and religious activities in 2016-17. Each FCRA-NGO organises multiple financial transactions in receiving and utilising foreign contribution.

Core industries register 4.7% growth in - April 2018

As per to index of 8 core industries published by Ministry of Commerce and Industry, 8 core infrastructure sectors raised by 4.7 percent higher in April 2018. It was obsessed by healthy performance in segments like coal, natural gas and cement. Sector wise breakaway in April 2018 Coal production augmented by 2.6 percent. Crude Oil production deteriorated by 0.8 percent.

Natural Gas production grown by 7.4 per cent. Petroleum Refinery production grown by 2.7 percent.

Fertilizers production grown by 4.6 percent. Steel production augmented by 3.5 percent. Cement production grown by 16.6 percent. Electricity generation grown by 2.2 percent. Core industries

Key objective of this scheme is at encouraging people to give information about benami transactions and properties as well as income earned on such properties by such hidden investors and beneficial owners.

Important Highlights

- In the new rewards scheme, a reward up to Rs
 1 crore will be given to those who can give
 specific information in the prescribed manner
 to the Joint or Additional Commissioners of
 BPUs (Benami Prohibition Units) in
 Investigation Directorates of Income Tax
 Department about:
 - Benami properties , transactions, and proceeds from such properties which are to be actionable under Benami Property Transactions Act, 1988, as amended by Benami Transactions (Prohibition) Amendment Act, 2016.
 - Substantial evasion of tax on income or assets in India which are actionable under the Income-tax Act, 1961 People of foreign origin would also be eligible for such a reward if they

provide the required specific information.
- The identity of the people giving information

will be kept strictly confidential.

Other than this, the Government has also introduced a reward of up to Rs 5 crore to those people who can share specific information regarding income and assets actionable under Black Money (Undisclosed Foreign Income and Assets) and Imposition of Tax Act, 2015.

- The amount has been kept high to make it attractive to potential sources in foreign countries.
- This same act was introduced by the Union Government to investigate and assess income and specific assets kept in foreign countries by people taxable in India, recover tax on it and take other actions like penalty and prosecution.

Did know? vou The new reward scheme supersedes the earlier scheme, issued 2007. The reward in Government initially amended Benami Property Transactions Act, 1988, by Benami Transactions (Prohibition) Amendment Act, 2016 to make the this law stronger.

Cauvery Water Management Authority formed by - Central Government

Following guidelines from Supreme Court, the Central Government has constituted the Cauvery Water Management Authority to address the disagreement over sharing of river water among Tamil Nadu, Karnataka, Kerala and Puducherry. In February, 2018 ruling, the Supreme Court had guided centre to set-up the Cauvery Water Management Authority within 6 weeks. In the same judgement, the court had also improved Karnataka's share in Cauvery Water a little bit.

- Remaining 4 will be part-time associates from states. The chief mandate of the Cauvery Water

The Cauvery Water Management Authority will also formulate an annual report covering o its activities during the previous year.

Role of Central Government

The central government will deliver help in execution of the modified award in case of any of the state $or \circ$ UT parties including Tamil Nadu, Kerala, Karnataka and Puducherry, that do not collaborate in executing the decision of the tribunal. Primarily, centre o will pay Rupees two crores for the functioning of the authority.

The main aim of the day is to recognize the pain suffered by children worldwide who are the victims of physical, mental and emotional abuse. The day confirms the United Nation's promise to shielding the rights of children. Its work is directed by the Convention on the Rights of the Child, which is the most quickly and extensively ratified international human rights treaty in history.

Important Highlights

- In current years, the violations cases against children has augmented in many conflict zones.
- As per to the UNICEF, violence has become a devastating situation child worldwide, as they are either being killed in continuing conflicts/suicide attacks or getting frozen to death while fleeing from active war zones.
- Data suggest that in the month of January only, rising violence in Iraq, Libya, Palestine, Syria and Yemen sued the lives of minimum 83 children.
- Therefore, the situation calls for immediate remedial measures to safeguard the 250 million children living in nations and areas exaggerated by conflict from being targets of violence.
- More wants to done to promote international humanitarian and human rights law and to make sure responsibility for violations of the rights of children.
- The 2030 Agenda for Sustainable Development consists of a universal master plan to safeguard a better future for children.

- Gopabandhu Sambadika Swasthya Bima Yojana has is effective from June 1st, 2018 and will primarly covering approximately 3200 media-persons and their families.
- The insurance coverage will be valid for cashfree treatment in government as well as in private hospitals.
- The scheme will also cover the injuries and illness suffered by journalists while on duties.
 Name of Scheme
- The scheme has been called after Gopalbandhu Das, who was a prominent social worker, political activist, media-person, poet and author from Odisha.
- His contribution to art, culture and society of Odisha received him the epithet of Utkalmani.
 His contribution to reporting in the state was short but extraordinary.
- In the decade of 1910, he had released a monthly literary magazine Known as 'Satyabadi' to educate the masses.

India receives first shipment of cheapest LNG from Gazprom Russia on - 4th June 2018

India received 1st shipment of its much cheapest 'Liquefied Natural Gas' from Russian supplier Gazprom, on June 4th , 2018. The Liquefied Natural Gas has been issued at a price approximately USD 7 per million British Thermal Unit. This price is near to 1.5 USD cheaper from the Liquefied Natural Gas imported from Qatar, which is India's biggest and major supplier of Liquefied Natural Gas. This price value is also 1-1.5 USD per mmBtu

As per to the official information, India's total natural gas generation in 2017-18 was 32.64

billion cubic meters of which 22.01 billion cubic meters is offshore production while 10.63 per cent is onshore production.

- However, presently, approximately half of Natural Gas request is fulfilled by imports.
 India's natural gas import dependence in 2016-17 was close to 45 per cent. Presently,
 India is 4th largest importer of Liquefied of Natural Gas.
- Natural Gas is one of the crucial inputs for generation of power and producing products in fertilizer and steel industries. The present of government policy also impulses towards a gas-based economy by increasing the portion of environment friendly of fuel in the energy bag to 15% from present 6.2%.

India's Gas Deals

- o Presently, Qatar is major supplier of Natural Gas to India. The current shipment from o Russia has come under a 20-year deal among India's State gas company GAIL India Ltd and Russian supplier Gazprom.
- A few weeks earlier, India had also imported its 1st ever Liquified Natural Gas cargo from United States under a long-term import contract.
- The government policy is to enlarge the Liquified Natural Gas import basket to complete any eventuality due to geopolitical/economic reasons.

RBI organises 'Financial Literacy Week' from - 4th June 2018 to 8th June 2018

The RBI is planning "Financial Literacy Week" around the country from June 4th to

June 8th, 2018.

Key Highlights

- The week will aim on 4 consumer protection messages like know your liability for unauthorised digital banking transaction and good practices for a harmless digital banking experience.
- Among different messages, the subscribers will be informed via banners/posters that in case of unauthorised electronic transaction, if the bank is well-versed within three days, the liability of the account holder is nil.
- Further, the resolution of the criticism is to be done by the bank anxious within a period not more than 90 days from the date of receipt of the complaint.
- Besides, banks have also been informed to spread awareness about Banking Ombudsman scheme of the Reserve Bank of India.
- The week will see contribution from bankers, financial literacy counsellors and other shareholders to generate awareness regarding the similar concern.

Other Details

To quicken the level of outreach of the initiative, Reserve Bank of India has planned a pilot project for financial literacy in 80 blocks of Nine states, in which six NGOs have been listed themselves in Depositor education and awareness fund.

Reserve Bank of India has also inked a deal with Ten banks to deliver financial education. The targeted groups of this initiative will be farmers, industrialists, school going students, senior citizens and self-assisted groups.

Government launched 'Suvidha'affordable, biodegradable sanitary napkin on - 4th June 2018

The State Union Minister for Chemicals & Fertilizers, Mansukh L Mandaviya, released the 'Janaushadhi Suvidha', oxo-biodegradable sanitary napkin, under the Pradhan Mantri Bhartiya Janaushadhi Pariyojana in Delhi on June 4th , 2018. The affordable sanitary napkin will now be accessible at more than 3600 Janaushadhi Kendras operating in 33 states and UTs across the

Key Highlights

- o The normal price of sanitary napkins present in the market presently is approximately Rupees eight per pad, while the Suvidha napkins will be accessible at Rupees 2.50 per sanitary pad.
- The move will deliver the basic hygiene need aid inexpensive for the underprivileged females.
- These pads also come with a special biodegradable additive which in contact with oxygen easily degrades after being discarded.
- As per to the National Family Health Survey 2015-16, approximately 58% of females aged 15-24 years utilise local pads and tampons.
- Further, about 78% females in cities practice hygienic methods during menstrual period, however, only 48% females in villages have access to clean sanitary pads.
- Centre proposes to ban on obscene depiction of women on -Internet

The Ministry of Women and Child Development projected modifications on June 4th, 2018, to the Indecent Representation of Women (Prohibition) Act, 1986 with an objective to restrict indecent and offensive depiction of women on internet.

The modifications were projected following the government received the inputs from the parliamentary standing committee to study a bill to take the law up to date and also from the National Commission for Women. Proposed

Amendments

The Centre projected modifications to broaden the scope of the Indecent Representation of Women Act to comprise digital and internetbased communication facilities.

Once the Parliament approves the projected modifications, the indecent representation of women in digital forms via text and online messaging facilities will be taken as an crime and will have penalties same to those under the Information Technology Act, 2000.

The ministry also suggests a fine of Rupees two lakhs and a custodial term of up to 3 years.

It suggests modifications in the definition of 'advertisement' to including digital form of hoardings including the SMS and MMS. It also projected to modify the definition of 'distribution' of material i.e. publishing and uploading it electronically.

It also proposes modifications in Section 4 of the Act to have that no person shall publish/distribute any material which consists indecent representation of women in any method. The government has also projected to contain hoardings in the Act as it is limited to traditional media consisting of books, we change your life

Centre gets go ahead from SC for -Reservations in Promotions

The Supreme Court has permitted Centre to proceed with reservation in promotion for SC/ST employees according to the law. From the centre's behalf, the Additional Solicitor General Maninder Singh had delighted **Supreme** Court to permit standstill promotions, according to mandate of the constitution. This appeal was acknowledged by Supreme Court bench hearing the case. Reservation in **Promotions** Reservations in promotions are instructed by Article 16 (4A) of the constitution. This article permitting provision and permits the state to for reservation deliver in concerns SC/ST promotion to which in its estimation were not sufficiently represented in the services.

Did know? With respect to the reservation in o advancements in government occupations, the SC verdict in Nagaraj Case that notion of creamy layer is not appropriate to SC/STs. 2 past cases in 1992 and in 2005 had allocated with the concern of creamy layer for OBCs. On this basis, the centre had delivered an order in 2017 outspreading reservation in promotions to SC/ST employees above 5 years from November 16th,1992. This government order was dared in Delhi High Court. The Delhi High Court suppressed the Central Government order and thus, the advancements standstill. came to Central Government later contacted Supreme

Court for relief and the present SC order delivers that much required relief to Centre.

Uttarakhand to ban use of polythene from - July 31st 2018

The Government of Uttarakhand has finalised to totally ban the use of polythene plastic from July 31 st , 2018. The initiative is focused at reducing rampant utilisation of plastic, which is majorly becoming a mega environmental challenge. The declaration was done by the state on the eve of World Environment Day on June 5 th , 2018. Key Highlights

- All the polythene merchants in Uttarakhand have been informed to finish the plastic stock earlier July 31 st.

President Ram Nath Kovind approved the promulgate the Insolvency and Bankruptcy Code (Amendment) Ordinance, 2018 on June 6 th , 2018. The Regulation provides noteworthy relief to home-buyers by recognising them as financial creditors. Home-buyers: Biggest beneficiaries of the ordinance

- From now onwards, home-buyers will have depiction in the Committee of Creditors and will be an essential part of the decisionforming procedure.
- Home-buyers will have the authority to initiate a resolution procedure against the bankrupt real estate firms and get their money returned.
- It will also permit home-buyers to appeal Section 7 of the Insolvency and Bankruptcy Code (IBC), 2016 against sinful developers. Insolvency and Bankruptcy Code (Amendment) Ordinance 2018
- The committee of creditors' voting rights of resolution plans will be restricted to 66% from previous threshold of 75%, and this initiative will help gear-up the resolution procedure.
- The Ordinance also delivers for a process to permit participation of security holders, depositors and all other classes of financial creditors in the meetings of the Committee of Creditors.
 - Section 29(A) of the IBC, 2016 has been revised to excused pure-play financial components from being ineligible on account of NPA.
- Taking into consideration the wide variety of disentitlements contained in Section 29(A) of the Code, the Ordinance delivers that the Resolution Applicant shall deposit an certifying affidavit for its entitlement to bid.
- Promoters of organisations with business about Rupees 250 crores will be permitted for bid.

The ordinance suggests to facilitate implementation of the resolution strategy by the successful bidder.

- Applicant to get essential statutory clearances from central, state and other the ruling classes.
- The other amendments brought about by the Ordinance are non-applicability of suspension period to implementation of guarantee; and liberalising terms and conditions of provisional finance to enable financing of corporate debtor.

Repo rate/repurchase rate, is the rate at which Reserve Bank of India loans to banks for small periods.

When Reserve Bank of India upsurges the repo rate, this is generally known as tight policy monetary stance. Reverse Repo Rate Reverse repo rate is the rate of interest at which the Reserve Bank of India borrows funds from other banks in the short term. This is done by Reserve Bank of India selling government bonds securities or banks with the promise to buy them back at an upcoming date. The banks practice the reverse repo

ability to deposit their short-termed excess funds with the Reserve Bank of India and receive interest it. Reserve Bank of India can decrease liquidity in the banking system by growing the which rate at borrows from banks. When the Reserve Bank of India increases the Reverse Repo, it means that now the Reserve **Bank** India will provide additional interest on the money which it borrows from the banks. An upsurge in reverse repo rate means that banks receive higher returns by lending to Reserve Bank of India. This

specifies a hike in the deposit rates.



Redemption of principal at maturity

- In the case of Medium and Long-Term Government Deposits, the reclamation of principal at maturity will be either in gold, or rupees equal of the value of placed-gold at the time of reclamation, as per to the preference of the account holder.
- However, any pre-mature reclamation of Medium and Long-Term Government Deposits shall be only in Rupees.
- In case of reclamation of the gold-deposit, an organizational charge of 0.2% of the Rupees value will be charged from the depositor.







Union Government collaborates with Google for flood forecasting on - 18th June 2018

India's top technical firm in the field of Water Resources- Central Water Commission, on June 18 th, 2018 inked an Agreement with Google for flood forecasting. Union Minister for Water Resources, River Development and Ganga Rejuvenation, Nitin Gadkari has showcased that partnership with Google will benefit in effective flood management in India.

Agreement between Central Water Commission and Google

- would utilise updated technology of Google for Artificial Intelligence, machine learning and geo-spatial mapping for actual management of water resources in the field of flood forecasting.
- The contract includes distribution of flood related news to the people by the distribution platforms established by Google.
- This contract will assist crisis management firms to deal extreme hydrological programmes in a much better manner. The data would be dispersed with a lead time of about three days.
- For the flood season of 2018, flood forecasting would be accomplished on trial and the same would be mounted in the future.

Importance

 The partnership between the Government and Google on flood forecasting is believed to complete the much-awaited mandate of the residents of the flood prone areas for flood warnings with adequate lead time.

- o It will save huge money that government have to be spent on getting high resolution Digital Elevation Model, high end computational resources and evolving dissemination platforms used by the people.
- This cooperative initiative is anticipated to be a milestone in flood management and in justifying the flood losses.

US President Donald Trump orders US Military to form 'Space Force' on - 18th June 2018



Governor's Rule imposed in Jammu and Kashmir, as approved by - President Ram Nath Kovind

President Ram Nath Kovind has given his approval to execution of Governor's rule in J&K. This is the 8th time in the past 4 decades Jammu and Kashmir has been under Governor's rule and 3rd time under Jammu and Kashmir Governor N.N.Vohra time period.

Key Points

• Presidential consent was received following Jammu and Kashmir Governor N.N.Vohra passed his report to President commending execution of Governor's rule in the state following PDP-BJP government malformed with BJP finishing the 3 years old association with PDP, prior to conclusion of 6 years tenure of the present Assembly which was going to finish in March, 2021.

- None of the other major political parties showed their interest in continuing any alliance for government in the state.
- With Governor's rule, Jammu and Kashmir Legislative Assembly has been put under suspension.

More about Governor's Rule in J&K

- In case of disappointment of constitutional body in any Indian state, President Rule is executed under Article 356 of the Constitution.
- But in case of Jammu and Kashmir, according to Section 92 of state Constitution, Governor's Rule is executed in the state only after the harmony of the President of India. During this, State Assembly is either suspended or dissolved.
- If the Constitutional machinery is not reinstated earlier to the expiry of this 6 months period, the provision of Article 356 of the Constitution of India is prolonged to Jammu and Kashmir and the President's rule is executed in the State.

RBI revises housing loan limits under Priority Sector Lending on - 19th June 2018

The RBI reviewed the increasing housing loan limits under Priority Sector Lending, on June 19 th , 2018. The housing loan restrictions were reviewed to bring union of the Priority Sector Lending rules for housing loans with the Affordable Housing Scheme of the Union Government and to provide an impetus to low-cost housing for the EWS and low-income sections. Priority Sector Lending loans are relatively inexpensive than market interest rate.

- Housing loans of up to Rupees 35 lakhs for residential purpose estimate less than Rupees 45 lakhs will now be considered as Priority Sector Lending to boost the low-costing group.
- The housing loan limitations for suitability under PSL will be reviewed to Rupees 35 lakhs in Metropolitan centres and to Rupees 25 lakhs in other centres.
- However, for being stated as priority section,
 the total cost of the residence in the metropolitan centre with population of 10 lakh and above and at other centres should not go beyond Rupees 45 lakhs and Rupees 30 lakhs, correspondingly.
- The present family income limit of Rupees two lakhs annually for getting the loans for housing projects for Economically Weaker Sections and Low-Income Groups now altered to Rupees three lakhs annually and Rupees six lakhs annually, correspondingly.
- These upgradations have been done according to the salary criteria specified under the Pradhan Mantri Awas Yojana.

World's first International Centre for Humanitarian Forensics launched in Gujarat on - 20th June 2018

The World's 1st state-of-the-art International Centre for "Humanitarian Forensics" was initiated on June 20th , 2018, at the Gujarat Forensic Sciences University, Gandhinagar, Gujarat. The centre is a combined venture of the Regional Designation of the International Committee of the Red Cross in India, Bhutan, Nepal, Maldives and Gujarat Forensic Science University.

Key Highlights

 The centre will help humanitarian efforts during crises and natural disasters like the work done by Red Cross during the Gujarat Earthquake.

- It would not only aid in honorable and proper management of the dead bodies during disasters but also in their credentials.
- The combined project signifies how humanitarian work will look like in upcoming time. It will join local and international proficiency to build capacities beforehand disasters hit people.
- The Centre will carry out different academic and professional programmes, research and deliver technical proficiency to support operations in the field of humanitarian forensics.
- The Gujarat Forensic Sciences University will operate various courses both PGs and PGdiploma courses in Humanitarian Forensics.

Gujarat government launched Wind-Solar Hybrid Power Policy-2018 on - 21st June 2018

The state government of Gujarat declared its Wind-Solar Hybrid Power Policy for 2018 on June 21 st, 2018, to encourage formation of wind and solar energy projects at single location.

Key Highlights

- The Wind-Solar Hybrid Power Policy 2018 will be effective for 5 years and it will issue inspiration to renewable power fabricators supplying to the grid and to those having confined use.
- The policy would permit the designer of a present solar project to utilise the similar land for forming wind and solar power plants and at the same time it would also permit them to utilise the communal transmission line to abandon the energy.
- A power project could also be formed on a terrestrial being utilised for wind farms.
- The welfares of the new policy will be appropriate for a time period of 25 years. The

power produced from wind-solar hybrid o projects will be excused from energy charges.

- The policy would also deliver 50% discount for cross-subsidy surcharge and extra surcharge when the produced energy is traded to a 3rd party.
- For the captive subscriber, the hybrid projects will have wide-ranging waiver on crosssubsidy extra-charge and added surcharge. The projects will also succeed for 50% reduction in wheeling charges and distribution loss.

- It is HQ in Geneva, Switzerland.

United Nations Human Rights Council is formed of 47 United Nation member states which are nominated by United Nations General Assembly with specific number of seats assigned for each member. Members work for 3 years terms and can work only 2 terms in a continuation.


Jeff Amazon CEO Bezos becomes world's richest man study by - Forbes World's Billionaires list

Canada legalises recreational use of marijuana nationwide Cannabis Act

The Canadian Parliament has Cannabis Act, which is a landmark law that legalizes frivolous usage of marijuana around the nation. It makes Canada the first G7 nation to legalise drug's recreational usage and the 2nd to have a nationwide, legal marijuana market, after which Uruguay got permission in December 2013.

Key Facts

- The law controls and regulates the utilisation, production, sale and distribution of the drug.
- It permits adults to possess about 30 gms of dried cannabis in public, but least legal age to buy and devour the drug has been set nationwide at 18.
- It makes illegal to possess above 30 gms of cannabis in public, grow above 4 plants per house and to purchase from non-licensed dealer.
- It issues rigorous penalty of jail about fourteen years if someone caught selling drug to minors. With the approval of the bill, Canadians will be enable to buy and devour marijuana legally as early as September 2018.

Marijuana

Marijuana is greenish-grey mixture of dried leaves, stems, seeds and flowers of Cannabis plant. It is utilised as painkiller for medical problems including cancer, nervous system diseases, glaucoma, migraines and many more and also utilised to treat nausea and improve appetites for people with AIDS and other chronic diseases.

Did you know?

Cannabis is permitted for medicinal use in fourteen European nations, Argentina, Israel, Puerto Rico, Mexico, Panama, Turkey, Zambia

Draft on cross- border insolvency resolution releassed by - The Ministry of Corporate Affairs

The Ministry of Corporate Affairs has published policy on cross-border insolvency to fortify Insolvency and Bankruptcy Code. It will assist banks access external assets of firm undergoing resolution. In the same way, Indian establishments will also be needed to unite with overseas creditors to domestic firm.

Need

The present Insolvency and Bankruptcy Code offers for 2 Sections 234 and 235 relating to cross-border

insolvency but these are not sufficient to efficiently deal with default cases of domestic business debtor having assets and actions outside India. In many of continuing cases under Insolvency and Bankruptcy Code, various firms have assets and operations outside India, for which permissible outline is needed to deal foreign assets. Current provisions only permit Central government to enter into MoU with overseas nation for enforcing provisions of Code. 2nd, the government can release a request letter to nation outside India looking forward data. The draft standards have now been released to plug these dodges and have any effective

Key Points

- The drive was initiated on voluntary grounds to spread awareness and inspire users to accept the rules.
- It will outcome in substantial energy savings and also decrease Greenhouse Gas Emission. Every single degrees rise in temperature of ACs consequences in protection of 6 percent of electricity utilised.
- After 6 months of mindfulness campaign, Ministry of Power will take into the consideration of the proposal of making labelling of ideal temperatures in Air-Conditioners obligatory.
- Labelling of ideal temperature by AC producers will advantage usera, both from the economic and health point of view. It will also outcome in savings of 20 billion units of power every year.

Scientific reasons

- The normal human body temperature is about 37 degrees Celsius.
- Lesser temperature approximately 18-21 degrees measured by ACs especially in huge number of marketable firms including hotels and offices is not only scratchy but is also insalubrious.

Indian navy agreed to to institute Coordinated Patrol with navy of which country – Bangladesh

India and Bangladesh have decided to organize Coordinated Patrol as an annual exercise among navies of both neighbouring nations. The 1st edition of Coordinated Patrol among both navies was initiated by Indian Navy's Chief Admiral Sunil Lanba during his official visit to Bangladesh. The objective of the Navy Chief's visit was to combine bilateral defence relationships among India and Bangladesh and to discover new paths for naval teamwork.

Kev Points

The 1st edition of combined patrol exercise was organised under military collaboration of both nations. It witnessed participation of 4 maritime patrol aircraft, 2 from Bangladesh Navy and 2 from Indian navy, and 4 frigates, again 2 from Bangladesh Navy and rest 2 from Indian navy. During the combined patrol, naval forces of both the nations shared data via naval announcement and understanding.

The warships and Patrol Aircraft mutually patrolled from Bangladesh's sea territory and sailed towards the Indian territory in Bay.

Significance

The institution of Coordinated Patrol-CORPAT among India and Bangladesh is measured as major step towards improved operational collaboration between both naval forces. The combine patrol will assist to control maritime crimes and will restrict various sea smuggling and piracy in Bay of Bengal. Presently, both navies are patrolling their appreciated water territories 24-hour on individual bases.

International Day Against Drug Abuse and Illicit Trafficking observed on – 26th June

By resolution 42/112 of 7th December 1987, the UN General Assembly finalised to celebrate 26th June as the "International Day against Drug Abuse and Illicit Trafficking" as an appearance of its willpower to reinforce action and collaboration to attain the goal of a drug abused free intercontinental society.

Saudi Arabia lifts ban on Female drivers

In a first historic drive, females across Saudi Arabia were lawfully permitted to drive for the 1st time since 1957 on June 24th, 2018. Thus, it ends the world's last restriction on female drivers which was recognised as a symbol of female's repression in the strongly conservative Muslim kingdom.

After the removal of restrictions, females in Saudi Arabia started their engines and measured the roads, marking the moment they had waited since the issuance of the royal decree by King Salman on September 26th, 2017 to remove the driving prohibition on females.

Following the royal decree, driving schools for females were started in the Saudi Arabia. Female driving instructors, who got driving licences abroad were presented with the teaching posts. As approximated, three million females are believed to drive in the nation by 2020.

Royal Decree ending the driving ban on females Saudi Arabia King Salman on September 16th, 2017 ordered a royal decree that permits females to drive cars. The end of the restriction was ordered as part of the reforms forced by King's young son, Crown Prince Mohammed bin Salman.

The Royal Decree ordered the set-up of a

set-up in the policy papers of 2009 "Political Declaration and Plan of Action on International Cooperation towards an Integrated and Balanced Strategy to Counter the World Drug Problem", which demarcated action to be taken by member states and objectives to be attained by 2019.



It will cover about 12.400 farmers from 33 different districts. The estimated cost of the project approximately Rupees 870 crores and it will 175 produce megawatts electricity.

More about Suryashakti Kisan Yojana

- The scheme intentions at empowering farmers of state to produce their own electricity with the help of solar energy and benefit replication of their income.
- Under it, farmers of state having present electricity connection will be issued solar panels according to their consumption needs.

FSSAI proposes life imprisonment, Rs10 lakh fine for food adulteration on - 26th June 2018

The FSSAI on June 26th, 2018 suggested stringent punishment for those contaminating food products after the Supreme Court order. Now, those contaminating food products

could have life imprisonment and penalty of about Rupees ten lakh. The commendations are the part of amendments projected by the Food Safety and Standards Authority of India to amend the Food Safety and Standards Act, 2006.

Key amendments to the Food Safety and Standards Act, 2006

- The controller has projected a sum of 100 modifications to the Act and has sought public remarks by July 2nd, 2018.
- The policy suggestion recommends insertion of Section 59 in the Act that explains the penalty for the food adulterers with penalty of seven years or life imprisonment besides a fine of Rupees ten lakh.
- It suggested formation of the state food safety authorities to impose the law in letter and spirit.
- It suggested rise in the penalty for obstructing, impersonating, intimidating and threatening and assaulting a food safety officer. It suggested custody of not less than six months and about 2 years, besides penalty of up to Rupees five lakh. Presently, the custody in such cases is up to three months and fine is about Rupees one lakh.
- The other modifications include regulation of exported food products under the FSS Act. Currently, it covers only sale of food items in domestic market and also imported food items.

Draft Act to replace UGC with Higher Education Commission proposed by - Government

The Union Ministry of HRD projected a draft bill on June 27th, 2018 to revoke the UGC and form the Higher Education Commission of India, with an initiative that goals to improve higher education in India. The Act entitled "Higher Education

Commission of India Act, 2018 renovates UGC Act, 1951 and its parent legislation entirely. The Higher Education Commission of India Act, 2018 is projected to be announced in Parliament in the forthcoming monsoon session.

Provisions of the Higher Education Commission of India Act, 2018

- o In continuation with the Narendra Modi government's Minimum Government, Maximum Governance policy, the Act foresees HECI to aims exclusively on academic matters.
- The major emphasis will be on academic quality with focus on enlighten learning results, academic performance assessment by institutions, mentoring of institutions, teachers training o and use of technology and many more.
- The Higher Education Commission of India will be supported with penal powers to order closing of institutes that violate norms and impose penalties where required.
- The Higher Education Commission of India will not incorporate the AICTE and NCTE. The legislation's governing All India Council for Technical Education and National Council for Teacher Education will be revised to take changes, if required.
- The important emphasis of the NCTE will be on justifying the over governance of institutions and bring-in revelation grounded regulatory command.
- This fresh commission will establish norms for opening and closing of institutes, deliver better flexibility and will set standard selection norms for critical leadership posts at institutions across ranges.

Oxytocin formulations ban to come into effect from -1st July 2018

The Ministry of Health & Family Welfare has banned the production of Oxytocin compositions for domestic usage and public area only from July 1st , 2018. Oxytocin formulations ban from 1st July 2018

- The import of Oxytocin and its compositions is also restricted. From July 1 st 2018, private producers will not be permitted to produce Oxytocin for domestic usage.
- Only Public-Sector firm, Karnataka Antibiotics & Pharmaceuticals Ltd, will produce Oxytocin for domestic use from July 2018 onwards.
- Do Oxytocin compositions for domestic usage will be delivered by Karnataka Antibiotics & Pharmaceuticals Ltd to the authorised hospitals and clinics in public and private sector on direct basis.

Case Details

- Dr.Shamshad Akhtar, reached Paris on June 24th, 2018 along with delegates of the financial monitoring team to fight the nation's case and requested the Financial Action Task Force to exclude Pakistan from its grey list.
- In compliance with the Financial Action Task Force's references, the Securities and Exchange Commission of Pakistan, on June 20th, 2018 supplied the Anti Money Laundering and Countering Financing of Terrorism Regulations, 2018.
- Previously, on June 8th, 2018, the National Security Committee- Pakistan had reiterated its promise to collaborate with Financial Action Task Force in attaining common objectives and shared goals.

Decision taken during FATF Plenary meeting in February 2018

- Financial Action Task Force had previously taken the decision to place Pakistan on its "Grey List" during a plenary meeting in February 2018.
- At that time, China, Turkey and Saudi Arabia, heading the 6 countries Gulf Cooperation Council that votes as single bloc, were against Pakistan for placing in the grey list.
- According to Financial Action Task Force guidelines, 3 votes from the Financial Action Task Force's associates are desirable for not putting a nation in the grey list.

Emergency declared in Papua New Guinea over - Polio outbreak

public health emergency has been acknowledged in 3 Papua New Guinea provinces the nation as responds to its 1 st polio epidemic in 18 years when it was stated free of disease. According to the Health Ministry

According to the WHO, the virus was sensed in a 6 years old boy in April present year. it Later. diagnosed that the similar virus has been recognized in other healthy children in the similar location and communal.

As per to the World Health Organisation, Polio has no cure and can result into irretrievable paralysis. Polio primarily affects children under age group of 5. It can only be cured by giving a multiple vaccine dosages to children.

The public health emergency will continue in place for minimum one year, according to the Minister for Health Puka Temu.  Jaitapur Nuclear Power Plant
- o It is planned 9900 megawatts nuclear power oproject to work at Madban village of Ratnagiri district Maharashtra. State operated NPCIL is builder and machinist of this unit. It will be constructed under Indo-France Civil Nuclear Deal inked in December 2010.
- It will have six EPR outlined and developed by Areva of France, each with capacity of 1650 megawatts, thus sum of 9900 megawatts.
- EPR is 3rd generation Pressurised Water Reactors. The predictable cost of this project was approximately US \$15 billion.
- The layout of nuclear power plant comprises two major parts including nuclear island and turbine island.
- The nuclear island is core of nuclear power plant, while turbine island keeps important element which abstracts thermal energy from pressurized steam and translates it into electrical power.

- India and US 2+2 Dialogue format was decided among 2 nations during visit of PM Narendra Modi to United States in June, 2017. It was intended at replacing previous India-United States Strategic and Commercial Dialogue.
- It is expected to enhance strategic harmonization among both nations and maintaining peace and stability.
- It puts strategic, defence and security ties among the both nations at the front and centre stage.
- It protects India-US strategic association from disputes over business concerns and strongly division on economic mixing policies as business and salable issues that collided with strategic ties between both nations debated in Strategic and Commercial Dialogue previously. It is analogous to India-Japan 2+2 dialogue format among foreign and defence secretaries of the both nations.

OPCW given powers to identify those behind chemicals arms attacks in - Syria

The world's leading chemical weapons regulator, an Organisation for the Prohibition of Chemical Weapons as approved itself new powers to assist identify those answerable for chemical attacks in Syria. 82 associates of the Organisation for the Prohibition Chemical Weapons voted in flow of this suggestion presented by UK at special session of Conference of States Parties in The Hague. 24 nations including Russia, Iran and Syria cast votes against it. With improved powers, Organisation for the Prohibition of Chemical Weapons now can have placed in-place preparations to classify the committers of practice of chemical

weapons in Syria. Did know? you Till date, Organisation for the Prohibition of Chemical Weapons was only intelligent to say whether chemical weapons were castoff. It had inadequate power to only direct teams to unproven chemical weapons attack, gather samples and lure their assumptions. They were having only imperfect power of defining whether attack is chemical weapons or not. But whatever indication they turned up, they were not having authorities to point at specific nation or non-state actor as the culprit for the attack.

Organisation for the Prohibition of Chemical Weapons Organisation for the Prohibition of Chemical Weapons is a diplomatic group that promotes, manages and confirms the devotion Convention the on Prohibition Development, Manufacture. Storing and Usage of Chemical Weapons and on their Destruction. This convention outlaw's manufacturing, storing, and usage of chemical weapons and their forerunners. Organisation for the Prohibition of Chemical Weapons was recognized April 1997 and it is HQ in Hague, Netherlands. It was bestowed Nobel Peace Prize in 2013 for supervising global endeavour for perpetual and demonstrable removal of chemical weapons.

The National Statistics Day is observed every year on June 29th in India to generate public awareness about the significance of statistics in socio-economic preparation and policy formulation. - PC Mahalanobis was born on 29th June 1893 in Kolkata and passed away on 28th June 1972 in Kolkata.
- He was the 1st Indian statistician to get world recognition. In year 1933, he published the 1st Indian statistical periodical 'Sankhya'. He had initiated the Indian Statistical Institute and donated to the design of large-scale sample surveys.
- He also made ground-breaking research in anthropometry in India. He is also best known for the statistical measure Mahalanobis distance. The 2nd 5-year Plan had based on Mahalanobis's mathematical explanation of Indian economy.
- This plan had stimulated the development of heavy industry in India and well along known as Nehru-Mahalanobis model of economic development.

Did you know?

The Union Government had elected June 29th as National Statistics Day in 2007 in gratitude of notable contributions made by Late Professor PC Mahalanobis in the fields of statistics. Every year Ministry of Statistics and Programme Implementation and ISI selects specific subject for the day grounded on present national importance for attentive discussions and efforts throughout year to bring developments in designated area.
